## DIRECTOR'S REPORT

I think we can all be thankful that 2020 is now history and look forward to 2021. The EDC is pleased to provide the Economic Development Corporation's annual report for this past year. Through the many new challenges that were presented to us, we managed to bring new opportunities and jobs to our amazing city. I hope you enjoy this annual report.

One of our goals identified for 2020 was to market and lease our Industrial Incubator on Easterday Avenue. Our efforts proved successful, as we entered into a 3-year lease with Bay Mills Community College (BMCC), which will generate \$85,000+/year. This building is now home to Great Lakes Composites and Pro-Metrics. BMCC is providing much-needed upgrading and renovations and should be fully occupied in the coming weeks. We are looking forward to a long and successful partnership with these ventures.



Another goal for 2020 was to promote and market the former K-Mart site. Although the COVID crisis delayed the investment community, we have been in discussion with a development firm that has created re-use designs for a multi-use facility. We hosted weekly progress meetings, and we are hopeful that our efforts are successful.

There were several economic stimulus efforts in 2020, and the EDC administered three rounds of funding for local businesses. Partnering with the County EDC and EUP Regional Planning, over a million dollars was distributed in Chippewa County. We are thankful to the Michigan Economic Development Corporation for the funding and we stand ready for additional programs in 2021.

We were pleased to welcome Superior Forensic Engineering to our family of businesses in the EDC SmartZone. Jon and Kristi Olson provide forensic testing on automobiles of all makes. Their growth in our city and partnership with our University will lead to high-tech skills for our students.

Our community was once again recognized by the University of Michigan as an honored Michigan Community, compared to such cities as Marquette, Petoskey, Traverse City, and other cities. It is awarded annually, as Sault Ste Marie does many of the things that attract and retain businesses. This is the seventh year that we were recognized!

Crain's Detroit, a highly recognized publication did a series of reports about our community, which included several outstanding businesses and the EDC. We are appreciative of the positive message that was relayed state-wide and thank them for spending a few days in our town.

The Soo Locks Project is progressing, and we are working with the Corps of Engineers and General Contractors to identify their many needs. We established the Soo Locks Workgroup, which consists of local leaders of the community. We meet monthly to discuss how we can best assist with the project, incoming firms, and ensure that our local workforce is considered for employment.

In closing, we would like to wish Bob Matson all the best. Bob recently "retired" from our Board of Directors after 30+ years of service. We will miss his quiet leadership and extensive knowledge. Thank you, Bob! I would also like to thank Shane Miller and Greg Collins for being our City Commission liaisons.

# 2020 HIGHLIGHTS

Although the COVID-19 pandemic greatly limited our events and workshops this year, the EDC found new ways to engage with the community and carry out our mission of expanding and the local economy and fostering an economic spirit in the Sault.



January: our U.S. Coast Guard Vinyl Program continues to grow as new businesses join to show their support for our local Coast Guard community, many offering discounts.

February: the Soo Locks Workgroup is created. This subgroup of the Economic Resource Alliance meets monthly to maximize the economic impact of the Soo Locks reconstruction project in our area.

March: the Sault EDC hosted Sault High School's CTE Business Administration class for a tour of the SmartZone and a presentation that covered the fundamentals of economic development and starting your own small business.

March: the Sault EDC welcomes Superior Forensics Engineering to our SmartZone business incubator.

April: collaboration with the Chippewa County EDC, the Eastern Upper Peninsula Regional Planning and Development Commission, InvestUP, and MichiganWorks! to administer the Michigan Small Business Relief grant.

May: Work begins on LSSU's new Center for Freshwater Research and Education (CFRE). Current projections have the building ready to open in 2021. The EDC continues to assist in Brownfield funding through a \$1 million grant and \$1 million loan.

June: the EDC works with local businesses to create "Welcome Binders" to distribute to incoming Coast Guard families. These binders include pamphlets, brochures, menus, contact sheets, and more from local organizations.

June: The EDC, as well as several other local businesses and organizations, is interviewed by Crain's Detroit Business magazine, a statewide publication. A collaboration with EUP Intermediate School District, along with other partners, modified the previous Freshman Manufacturing Day into a virtual video library.

July: collaboration with the CCEDC, EUPRPDC, and MiWorks to administer the second phase of the Michigan Small Business Restart Grant.

August: Assists AgX Imaging in obtaining a \$25,000 MEDC site readiness grant

August & October: through a grant obtained from EGLE, the Sault EDC and the City of Sault Ste. Marie co-hosted two City-Wide Tire Disposal Day events.

September: our Industrial Incubator is leased in full to Bay Mills Community College for a three-year term.

October: Sault Ste. Marie is recognized by the University of Michigan in their annual eCities study. This is the seventh time the city has been recognized through the efforts of the EDC.

December: collaboration with the CCEDC, EUPRPDC, and MiWorks to administer the third phase of the Michigan Small Business Restart Grant.



**THROUGHOUT  
THE YEAR...**

The EDC hosted the Upper Peninsula Regional Blood Center for blood drives at the SmartZone in May, July, and October. The EDC also continued to plan for future redevelopment projects through investing \$4,000/year into a savings account. Progress to maximize the benefits of Foreign Trade Zone 16 in Chippewa County continued throughout the year, and we worked to modify LDFA geography and extend TIFA.

# OUR SMARTZONE TENANTS

Both Cardinal Plumbing & Heating and DPenzTech Consulting graduated from our SmartZone program this year. Although it is sad to see them go, it is always exciting to see our partners grow and expand. The SmartZone currently houses six business and has five office spaces plus light manufacturing space available to rent.



NORPRO is an Ontario based firm that began as a security company in 1980 and has since expanded to include technology, IT, maintenance, and business support solutions. In 2018, the company further expanded operations to become an international brand, with their first office in Sault Ste. Marie, MI. In the States, they serve as an innovative company, providing dynamic solutions to their customers. In 2020, NORPRO employed one full-time and one part-time employee and worked with multiple local contractors.

Osprey Technologies is a design and analysis engineering firm specializing in composite structures. Osprey employs 2FT and 2PT staff.



Superior Forensics Engineering, LLC was established in 2011 with the goal of providing enhanced automotive and forensic engineering expertise for a diverse group of clients and their products. They offer a wide range of services and design analyses to meet the unique requirements for each case. The Sault Ste. Marie location has 2 FT employees.

Ideas Production LLC is an engineering firm that serves a parent manufacturing firm in Alpena, MI. They chose to come to the SmartZone so they could work with engineering students at LSSU and Ontario partners. The SmartZone office currently has 6 employees, two of whom are PT.

## MARKETING SUCCESSES


- This year we received formal offers for several lots in our Air Industrial Park and anticipate future offers in the Industrial Park.
- After one year of vacancy, our Industrial Park Incubator was leased to Bay Mills Community College (BMCC) for Great Lakes Composite Institute, Prometrics, and Pearson Vue.
- This year saw the arrival of two new tenants in the SmartZone, Superior Forensics Engineering and BMCC.

## WEBSITE

SaultEDC.com has seen an increase in traffic throughout the past 12 months. Total site sessions for 2020 exceed 5,000 with over 3,000 unique visitors and an average use time of 5 minutes. Through regular website updates, streamlining the visitor experience, and improving SEO, we hope to keep these numbers on the rise throughout 2021 (and beyond).



## 2020 GROWTH & HIGHLIGHTS

- The Sault Ste. Marie International Seaplane Base was officially recognized by the FAA. The base (which sees 100+ visitors each year!) also received upgrades throughout the summer including new signage and paint touch ups to make the MI8 identifier visible from the sky.
- Increased partnership with City Department of Public Works, utilizing internal workforce to service equipment and install signs. The purchase of a large self-powered, loader mounted snowblower marked the first partnership between the airport/EDC and City Street Department. The two departments split the cost 50/50 at \$75,000 each.
- Prior to the COVID-19 pandemic, Great Circle Aviation Services continued to offer aircraft maintenance and repair classes to the community. Although postponed, classes will resume when it is determine safe to do so.
- GCA hosted a transponder certification technician in August. Pilots from all over the eastern Upper Peninsula flew in to attend the event.
- Worked with Prein & Newhof to develop a new Storm Water Pollution Prevention Plan. Staff became Storm Water Certified. New 5-year permit was received.
- Progress continues on certifying the airport as a Part 145 repair station with the FAA
- Rekeyed property and added additional security cameras
- Work began on decalling the airport courtesy cars
- Continued to market vacant lots in Air Industrial Park

## New Hires

This year, our Fixed-Base Operator, Great Circle Aviation Services, LLC hired three new, year-round employees to assist with airport operations. Alecia Stephens began as a part-time employee and is now the full-time Lead Aircraft (A&P) mechanic. Phil Kostelyk works as an A&P, and Orlando Garibay is a FT Equipment Operator/Mechanics Helper. Having additional staff has enabled the team to work on several aircraft at once.




Sanderson Field is an asset to the City of Sault Ste. Marie. Through services offered and jobs provided, the yearly economic impact exceeds \$1 million. For every dollar spent in 2019, the airport had a \$37 return on investment. In 2020, this ROI increased significantly to \$97 for every \$1 spent. -MDOT Office of Aeronautics CBA

# GROWTH & HIGHLIGHTS, CONTINUED:

- Continued discussions with MDOT Office of Aeronautics and the Federal Aviation Administration on the potential to join the the NPIAS (National Plan of Integrated Airport Systems) and secured letters of support from both Bay Mills and Sault Tribes.
- Compiled information from board members, airport documents, and old newspaper clippings to create a history page for the Sanderson Field website
- Type I Deicing was added to the services offered at the airport
- Staff attended the Michigan Association of Airport Executives conferences and received annual AV Fuel Training
- Sanderson Field's website saw a 70% increase in traffic over the past year. The site had a total of 2,159 visits, with 1,847 unique visitors that surfed an average of 2 minutes per visit. Facebook likewise saw an increase, with an end-of-year total of 297 followers.
- Work continues to regain MDOT Aero funding for rural airports to complete our taxiway project, at 4.7 million dollar endeavor, at a 90:10 ratio
- Continued planning for Phase II renovation of airport terminal that is set to take place in 2021-2022.

## Compass Rose Restoration Project



On Friday, September 11, the Northwoods Chapter of the Ninety-Nines gathered at Sanderson Field airport to repaint the weathered compass rose and enjoyed a luncheon hosted by Great Circle Aviation. The Ninety-Nines is a non-profit organization of women pilots that was founded in part by Amelia Earhart nearly 100 years ago, in 1929. The tradition of "airmarking," or, identifying airports to pilots, has been a central ambition to the organization since the 1930s.

The Northwoods chapter of the 99s is comprised of pilots from northern Michigan, eastern Wisconsin, and Sault Ste. Marie, Ontario. In continuation of 99s tradition, the group has added compass roses to several airports in the region, including Escanaba, Iron Mountain, Tomahawk, and of course, Sault Ste. Marie.

# COVID & BORDER CLOSURE

485 Total Aircraft Transited Sanderson Field in the last year. Of those, flight purposes were:

- 84 Business
- 239 Recreation (or personal travel)
- 64 Medical
- 44 Military or other governmental purposes
- 27 Customs Clearance
- 27 Training (flying lessons)

For contrast, these are the figures for the last six months of 2019:

- 513 Total Aircraft Transiting KANJ, comprising-
- 263 Private Aircraft
- 180 Corporate Aircraft
- 19 Government Aircraft
- 51 Resident Aircraft

In the final six months of 2019, 130 aircraft of Canadian or other foreign nation registry transited the airport or 25% of the total aircraft transiting during that period. In the entire year of 2020, only 6 non-U.S. registered aircraft transited or 2.3% of annualized 2019 numbers. Additionally, fuel sales for the 2020 calendar year were 26% of the annualized fuel sales for the 2019 calendar year.

Total persons transiting the airport for 2020 was 1,129, versus 1,275 for the last six months of 2019. Medical and military/governmental flights track roughly the same in both 2019 and 2020. All other types of flights were substantially reduced in 2020. Closures and other curtailed activities due to the coronavirus are the sole reason for these reductions.



In January 2021 Sanderson Field was covered in a 2-page feature article that went to all of Cloverland's membership in the Upper Peninsula. The marketing coverage was expansive and would have cost several thousand dollars.

# CHALLENGES AHEAD & PLANNING FOR THE FUTURE

The COVID-19 pandemic has brought a slew of unprecedented challenges for the entire community. In the year-end traffic report from the International Bridge Administration, traffic for the calendar year was at 340,318 which represents an annual decrease in traffic of 74.9%. Local businesses took an exceptional hit with stay-at-home orders, the closure of the Canadian border, and the resultant loss of business from both local and international patrons. Border closures additionally limited activity of the Bi-National Alliance and Twin Sault's development projects, such as last year's Business Beyond Borders conference. Stateside, the EDC was forced to postpone several annual events, including our business development workshops and our October Manufacturing Summit. Sanderson Field Airport saw a notable decrease in air traffic and likewise was forced to postpone events, including the weekly Aircraft Maintenance and Repair courses, and annual events such as Young Eagles Day and the Airport Open House and Movie Night.

Within the SmartZone, infrastructure remains lacking for incoming manufacturing businesses. As more manufacturing tenants move in, it is likely that we will need to share in additional costs as they lease out manufacturing space. We also need to find new ways of clearly defining the individual manufacturing spaces located in the back of the building, which is currently an open concept layout.

Our LDFA shortfall continues to be funded by TIFA III. Dark store cases and principal homestead exemptions continue to reduce any programmatic funding. The EDC has been able to rely on the Business Accelerator Fund through Michigan's Small Business Development Center and MEDC's Gateway Grant to continue to assist clients.

Issues facing the airport include limited hangar space (currently leased at 100% capacity) and funding the taxiway reconstruction and extension, a crucial upgrade estimated to be a \$5 million project. We are also looking to continue phase II of the terminal renovation project, which will add a pilot's area, a separate board room, and a storage room, as well as general painting, lighting, and flooring upgrades. We would also like to see the reinstatement of flight lessons and have planes available to rent. We will continue to discuss the lack of funding that's provided by MDOT Aero for General Aviation airports with Aero leadership and elected officials.

Our projects on the horizon include further development of the newly expanded Foreign Trade Zone — marketing, educating local business owners, and potential state and federal funding. Of course, we will continue to advertise our temporary office spaces for lease with the goal of filling our SmartZone. While the Industrial Incubator at 1301 West Easterday is currently rented, the sale of this aging facility may alleviate the cost of larger repairs in the future.

We have partnered with the Chippewa County EDC to complete a Housing Market Study for our City and County. This should be completed by the end of February and will give us a clear understanding of our current and future housing needs.
